The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt.- II) dated 23rd November, 2022 issued in exercise of the powers conferred under Section 5(6) of the Administrative Tribunals Act, 1985.

On consent of learned counsels for the contesting parties, the case is taken up for consideration sitting singly.

By filing a copy of an order No. 761 dated 03.08.2023 Mr. Ray, learned counsel appearing on behalf of the alleged contemnor submits that in terms of the Tribunal's order, respondent authorities have complied in toto the direction of this Tribunal passed in OA-1313 of 2016 dated 20.07.2022. In compliance to the direction of the Tribunal, Mr. Mitra, learned departmental representative shows a copy of report and submits that in compliance, now the pay of the retired employee has been fixed at Rs. 17,230/- as on 01.07.2006 (revised) and accordingly the pension has also been revised to Rs. 8,615/- p.m. Similarly the Gratuity has also been revised to Rs. 2,84,295/-.

Prayer of Mr. Ray to replace the name of Mr. Parag Ghosh as alleged contemnor/O.P. No. 2 by Mr. Maznu Dhali and designation to be changed as Executive Engineer, Electrical Sub-Division, P.W.D Baguihati, North 24 Pgs. is allowed.

Prayer of Mr. Mitra, learned departmental representative to replace the name of Ms. Yasodhara Roy Chowdhury as the Principal Accountant General with Mr. Atul Prakash is allowed.

Mrs. Mitra while going through the compliance report has raised certain objections and prays for liberty to file written objection by the next date.
