The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 536 - WBAT / 2J-15/2016 dated 26<sup>th</sup> August, 2022 issued in exercise of the powers conferred under Section 5(6) of the Administrative Tribunals Act, 1985.

The instant application has been filed praying for addition of party in paragraph 6 of the instant application. As per the applicant, vide order dated 29.04.2022, this Tribunal had directed to add fifteen candidates as Private Respondent in the instant application. Mr. M.N. Roy today has filed his 'Vokalatnama' and has submitted that he is appearing for all the amended parties as the instant application has been already been served all the eight candidates who are in service.

I have heard the parties and perused the records. It is noted that this Tribunal in earlier occasion vide order dated 29.04.2022 had directed the counsel for the applicant to add fifteen candidates as Private Respondents. However, as only eight persons joined in service and out of that one person resigned from service and the eight persons who are joined the service has been added as Respondent No. 4 to 12. Accordingly, the M.A. is allowed.

Applicant is directed to serve all the pleadings to the newly added party.
