Mr. Subir Sanyal, learned advocate for the applicants, referring to the averments made in paragraphs 5 to 7 of the M.A. 109 of 2021, submits that it is evident from pages 354 to 365 of the supplementary affidavit that as there are discrepancies in the OMR sheets, the Public Service Commission, West Bengal may be directed to supply answer keys of the written examination for the post of Fire Operator in the West Bengal Fire Services under the Department of Fire and Emergency Services of West Bengal, 2018. However, paragraph 8 of the miscellaneous application is not pressed.

Mr. Gautam Pathak Banerjee, learned advocate for the Public Service Commission, West Bengal opposes the prayer on the ground that the applicants are trying to hold a fishing enquiry at a belated stage.

Mrs. Sunita Agarwal, learned advocate for the State respondents adopts the submission made on behalf of the Commission.

Mr. Kamalesh Bhattacharya, learned advocate for the added private respondents submits that since some of the roll numbers of the candidates Form No.

mentioned in paragraph 8 do not match with the candidates in the merit list published by the Commission, no order may be passed on the miscellaneous application.

Considering the prayer made in the miscellaneous application, the Deputy Secretary, Public Service Commission, West Bengal, the respondent no.5 is directed to furnish the key answers of the written examination for the post of Fire Operator in the West Bengal Fire Services under the Department of Fire and Emergency Services of West Bengal, 2018 before the Tribunal on 23rd February, 2022. A copy of the key answer shall be furnished to the learned advocate-on-record of the applicant by 16th February, 2022.

As nothing remains to be decided in the instant application, the miscellaneous application, being MA-109 of 2021, is disposed of.
