The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt. – II) dated 23<sup>rd</sup> November, 2022 issued in exercise of the powers conferred under Section 5(6) of the Administrative Tribunals Act, 1985.

The prayer in this application is for substituting the names of the applicants in the Original Application being OA 426 of 2023. The applicants, Subhadra Choudhuri Marandi is the widow and Indrani Marandi is the daughter of the deceased Jiban Marandi. Jiban Marandi was the original applicant in OA 426 of 2023 which was heard and disposed of by this Tribunal after giving a direction to the Respondent authorities to process the proposal for change of nominee in the documents and communicate the final decision to the applicant. This order was passed on 19.9.2023.

It is submitted by the applicant's side that on 12.10.2023, Jiban Marandi expired leaving behind the applicants as his only legal heirs.

The Tribunal after hearing the submissions of Mr. Batabyal, which has not been opposed by Mr. Ghosh, learned counsel for the State respondents, is satisfied with such prayer for substitution. Let the names of Subhadra Choudhuri Marandi, widow and Indrani Marandi, daughter be added as applicants in OA 426 of 2023.
