The matter is taken up pursuant to the order contained in the Notification No. 638-WBAT / 2J-15/2016 (Pt.-II) dated 23rd November, 2022 issued in exercise of the powers conferred under the Administrative Tribunals Act, 1985 and the Rules framed thereunder.

In substance, the applicant by filing the present application (MA-35 of 2022) has prayed for substitution of her name in place and stead of the original applicant of the Original application (OA-909 of 2018) who has died on 07.07.2021 leaving behind her as his sole legal heir and representative.
