On consent of the learned counsels and the learned Departmental representative for the contesting parties, the case is taken up for consideration sitting singly.

It is the view of the Tribunal that in this matter, the respondent – Principal Accountant General (A&E) West Bengal is not required to be added as a party since the matter relates to only CAS / MCAS benefits and grant of Scale No. 15 as per ROPA rules. The Tribunal finds that there is no role for the Principal Accountant General (A&E) West Bengal in this application. Let the name of the Principal Accountant General (A&E) West Bengal, as proforma respondent No. 6 be expunged from the array of the respondents in this application.

Since the matter in this application involves various points of law and similar matters were earlier heard by a Bench comprising of two Members, both Mr.S.N.Ray, learned counsel appearing on behalf of the State authorities and Mr.B.Bhushan, learned counsel for the applicant submit that this matter be also placed before a Bench comprising two Members (Judicial and Administrative).
