In this application, being MA 66 of 2021, filed in connection with OA 19 of 2020, prayer has been made to grant leave to the respondent authorities to publish the results and marksheets of the applicant in connection with the recruitment process pursuant to the advertisement dated 20<sup>th</sup> December, 2019, issued by the Secretary and Controller of Examination, Health Recruitment Board. It appears from the order dated 16<sup>th</sup> January, 2020, passed in OA 19 of 2020, that interim order was passed directing the Respondent Nos. 3 and 4 to allow the applicant to submit an application in hard copy format for the post of Medical Technologist (RD) Grade-III without prejudice to the rights and contention of the parties subject to further order that might be passed. The marksheets and results of other candidates have been published. Due to the interim order the marksheets and results of the applicant could not be published. Prayer is to direct the respondents to publish the results and marksheets of the applicant.
