The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt.-II) dated 23rd November, 2022 issued in exercise of the powers conferred under Section 5 (6) of the Administrative Tribunals Act, 1985.

The prayer in this application is for recalling the order dated 06.05.2024 passed in CCP-85 of 2023. By this order, the Director of Health Services was directed to accept the resignation of the applicant Dr. Soumendra Datta and release from service. Having passed such an order, the contempt application was disposed of.

Submitting on behalf of the applicant, Mr. Ghosh and Mr. Roy, learned counsels point out that despite such a clear direction in CCP-85 of 2023, Mr. Siddhartha Neogi, alleged contemnor did not comply. Therefore, the need has arisen for the disposed Contempt application - CCP-85 of 2023 to be restored and heard again.

The Tribunal after hearing the submissions and examining the direction passed on 06.05.2024 is satisfied with such prayer. The prayer for recalling the order dated 06.05.2024 in CCP-85 of 2023 is allowed. CCP-85 of 2023 is restored to its original file and no.

Mr. Roy submits that in the meanwhile, the alleged contemnor, Dr. Siddhartha Neogi has been replaced by Dr. Debasish Halder as the new Director of Health Services. Liberty is given to amend the cause title and addDr. Debasish Halder as the alleged contemnor
