The counsel for the applicant has drawn our attention to the earlier order dated 11.12.2020, whereby the following order was passed :-

"It is noted that the second show cause notice was already issued on 07.01.2019 against which the applicant has submitted his reply on 18.02.2019, which was received by the Department on 19.02.2019. However, the P.S.C. had asked for certain documents on 25.10.2019 but no action was taken by the Respondents. Therefore, we direct the Respondent No. 2 to conclude the departmental proceedings within a period of six months and to take a final decision by way of passing a speaking and reasoned order as per rules and communicate the same from date of receipt of the order. In default, the proceedings should be vitiated. Accordingly, OA is disposed. Parties are directed to act on the Web Copy of the order."

The counsel for the applicant has further submitted that he has received the impugned final order dated 12.05.2021 on 12.08.2021 through his counsel and by Whats app and Email on 19.08.2021. Even in the meantime the respondent authority did not approach this Tribunal for extension of time to communicate the final order.

During the course of hearing, the counsel for the applicant has also referred Para 14 & 15 of the case reported (2009) SCC 180 Sethi Auto
