Considering the nature of the Miscellaneous applications being MA-95 of 2021 and MA-96 of 2021, both are heard together and a common order is passed.

It appears from the record that original application being OA-896 of 2018 was placed before the Hon'ble Bench on 24th May, 2019 and on that date, the Hon'ble Tribunal has been pleased to adjourn the case till 25th June, 2019.

On 25th June, 2019, the case was again adjourned till 4th July, 2019. On 11th March, 2019 an application had been filed for condonation of delay (MA 75 of 2019) in filing the original application being OA-896 of 2018.

Subsequently, on 4th July, 2019, MA-75 of 2019 (application for condonation of delay) and OA-896 of 2018 had been dismissed for default.
