The instant MA has been filed praying for condonation of delay in filing the original application.

As per the applicant, his father died on 21.09.2014. Subsequently, he made a representation before the authority for granting compassionate appointment in favour of him. Thereafter, the respondent authority vide Memo dated 05.07.2016 had asked the applicant to appear before the Chairman, Interview Committee on 15.07.2016 (Annexure-A/3). Thereafter the applicant appeared before the Interview Committee. However, till date no decision has been communicated to him. As the applicant is waiting for the decision of the respondents, some delay is occurred to approach before this Tribunal. Therefore, the counsel for the applicant has prayed for condonation of delay in filing the OA application.

In view of the above, MA is allowed. Delay is condoned.

During the course of hearing, the counsel for the applicant has fairly submitted that after condoning the delay, the authority would be directed to take a decision with regard to compassionate appointment within a stipulated period of time.

The counsel for the respondent has no objection to such proposition.

Accordingly, Respondent No. 2, Director of Health Services & Family Welfare is directed to take a final decision with regard to compassionate appointment of the applicant and communicate the same by way of reasoned and speaking order within a period of twelve weeks from
