The instant application has been filed praying for compassionate employment. The father of the petitioner Late Narayan Prasad Hazra working as G.D.A. Assistant under B.M.O.H, Belda Rural Hospital, Paschim Midnapore died in harness on 11.02.2011. Thereafter on 12.07.2011 the daughter of the deceased Monami Hazra duly submitted an application for compassionate employment along with all relevant documents including N.O.C. from her siblings. Thereafter the C.M.O.H, Paschim Midnapore forwarded the application papers alongwith the Three Mens' Committee report to Additional Director of Health Services (Personnel), Swasthya Bhawan for necessary action on 19.03.2019.

Thereafter several prayers were made to the concerned respondents for disposal of her prayer. However, till date no such decision has been made by the respondent No. 3. The petitioner prays for suitable direction may be passed by the respondent to expedite and dispose of the application.

In view of the above, Respondent No. 3, Additional Director, Health & Family Welfare Department is directed to dispose of the representation and pass reasoned and speaking order within a period of six weeks from the date of receipt of the order after giving an opportunity of personal hearing to the petitioner and communicate the decision to the petitioner within a period of one week thereafter. Accordingly, both the OA and MA are being disposed of with no order as to costs.
