Affidavit of service has been filed. Let it be kept with the record. The instant MA-238 of 2019 has been filed praying for recalling of the order dated 16.04.2019 which was dismissed for default. As per the applicant, thereafter he has engaged another lawyer i.e. the present counsel for the applicant directing him to make an application for restoration. However, the counsel for the applicant has submitted that due to some personal difficulty he could not file restoration application within time.
