his selection to the post of 'Constable' in in West Bengal Police under Krishnagar Police District, Nadia in the year 2019, both being Annexure- 'Y' and 'Z' herein, and to command them to act in accordance with law."

Relying on the Miscellaneous application, it is submitted by Mr.G.P.Banerjee, particularly with regard to the order dated 26<sup>th</sup> April, 2021 passed by the Learned Judicial Magistrate, 3<sup>rd</sup> Court, Krishnagar, Nadia passed in complaint case no. C-786 of 2018, as the complaint lodged by the complainant has been withdrawn and at present there is no impediment on the State authorities to issue appointment letter pursuant to his selection to the post of Constable in the West Bengal Police under Krishnagar Police District, Nadia, appropriate order may be passed. Having heard the learned advocates for the parties, since it is evident from the Order dated 26<sup>th</sup> April, 2021 passed by the Judicial Magistrate, 3<sup>rd</sup> Court, Krishnagar, Nadia, that it has been held that there is no scope of framing any charge against the accused persons as the case has been amicably settled and complainant has deposed that he would not adduce any further evidence
