> The matter is taken up by the Single Bench pursuant to the Notification No. 949-WBAT/2J-15/2016 dated 24th December, 2020, issued in exercise of the powers conferred under sub section (6) of Section 5 of the Administrative Tribunals Act, 1985.

> According to the applicant though he had already served the copy of the application and filed his affidavit of service earlier. However, on the earlier occasion, none appeared for the respondents. Thereafter, the counsel for the applicant had again sent notices to the respondents informing that the matter would be listed today i.e. on 21.04.2021. The counsel for the applicant has prayed for leave to file affidavit of service during the course of the day.

> During the course of the hearing, the counsel for the applicant has submitted that the father of the applicant died on 04.12.2005. Thereafter, he had made an application before the concerned authority asking for compassionate appointment. However, vide enquiry report dated 29.11.2016, the three-men enquiry committee had submitted enquiry report on 29.11.2016 by the CMOH, Murshidabad to the Joint Director of Health Services (Personnel). However, till date no decision has been communicated to the applicant. During the course of the hearing, the counsel for the applicant has fairly submitted that it would suffice the purpose of the applicant if the Principal Secretary to the Government of West Bengal, Department of Health & Family Welfare would be directed to take final decision with regard to the compassionate appointment of the applicant within a stipulated period of time.

> Though affidavit of service has been filed but none appeared for the respondents.
