The instant application has been filed praying for a direction to the authority to disburse the family pension in favour of the applicant. As per the applicant, she is the unmarried daughter of deceased employee. Thereafter her mother was getting family pension who died on 28.01.2019. Subsequently, she made an application before the authority on 06.02.2020 (Annexure-B) and prays for granting family pension. However, she has not been paid the family pension.

During the course of hearing, the counsel for the applicant has submitted that it would suffice her purpose if the authority would be directed to take final decision and make payment thereof.

The counsel for the respondent has submitted that they have no objection to consider her representation as per rules.

Heard the parties and perused the records.

It is noted that the applicant is having other three sisters.

In view of the above, Respondent No. 4, Superintending Engineer, P.W.D., Western Circle-I, Purba Bardhaman is directed to take final decision with regard to the eligibility of family pension and to communicate the decision by way of reasoned and speaking order within a period of twelve weeks from the date of receipt of the order. Accordingly, OA is disposed of. Applicant is directed to cooperate with the respondents in this regard.
