In view of the above submission, let the name of respondent no. 5, Secretary, Public Service Commission, West Bengal be expunged from the array of respondents.

Introducing the prayers in this application, Mr. B. Bhushan, learned counsel for the applicants submits that the primary prayer mentioned in the supplementary affidavit, prayer (e) is a prayer for direction upon the respondent nos. 1 to 3 to permanently redesignate the applicants as CDPO.

Appearing on behalf of the State Respondents, Mr. S.N. Ray, learned counsel assures to file reply on behalf of the State Respondents by the next date. Such directions where given by this Tribunal as well as Hon'ble High Court in this matter in the past.

Let the reply be filed positively by the next date and copy of the reply be served upon the learned counsel for the applicants. Rejoinder, if so wished, be filed in the
