The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 536 – WBAT / 2J-15/2016 dated 26<sup>th</sup> August, 2022 issued in exercise of the powers conferred under Section 5(6) of the Administrative Tribunals Act, 1985.

Affidavit of service has been filed. Let it be kept on record. However, Mr. S.K. Mondal has submitted that as none appeared for the respondents, he was directed to be appear by the Ld. Registrar. Therefore, today he is appearing and prayed that the Ld. L.R. may be directed to take appropriate steps in this regard. Prayer is allowed.

The instant application has been filed praying for following reliefs:

**“a) An order do issue directing the concerned respondent authorities to forthwith extend and/or grant the benefits, i.e. enhanced remuneration of the applicants as part time sweeper-cum-water carrier in terms of the G.O. No. 3727-F dated 20.05.2009 with effect from 01.06.2009 and also upon all the subsequent government orders regarding the enhanced remuneration of part time/daily rated/casual workers under the different establishment of the government and to release all the arrears from the date on which the said government order dated 20.05.2009 together with**

**18% interest p.a. (Eighteen percent interest per annum) from the date when the said order has become effective and to consider the said representation dated 17.01.2022.**

**b) An order do issue directing the concerned respondent authorities to transmit all the records before this Hon'ble Tribunal in ends of justice.**

**c) And to pass any other order/orders, direction/directions as this Hon'ble Tribunal deem fit and proper in the ends of justice.”**

As per the applicant, he had already filed representation dated 10.02.2021 (Annexure 'A'), which is still pending before the authority. During the course of the hearing, the counsel for the applicant has submitted that it would suffice his purpose if the Additional Chief Secretary, Animal Resources Development Department be directed to consider the case of the applicant by way of passing reasoned and speaking order with follow up action.

The Respondents have no objection to such proposition.

In view of the above, Additional Chief Secretary, Animal Resources Development Department is directed to consider the representation of the applicant treating this O.A. as a part of it by passing a reasoned and speaking order and communicate the same within a period of two months from the date of receipt of the order. Accordingly, the O.A. is disposed with no order as to costs.
