The matter is taken up by the Single Bench pursuant to the order contained in the Notification No.638-WBAT/2J-15/2016 (Pt.-II) dated 23<sup>rd</sup> November, 2022 issued in exercise of the powers conferred under section 5(6) of the Administrative Tribunals Act, 1985.

The prayer in this application is for a direction to the respondent authorities to give an appointment afresh to the applicant after setting aside the impugned memo No.1443 dated 02.11.2017 issued by the Deputy Secretary, School Education Department.

The applicant was selected by the Public Service Commission, West Bengal for the post of Head Master in Bengali Medium School. His first appointment was issued by the School Education Department to an English Medium Government Model School at Nayagram, Paschim Medinipur by Notification dated 06.06.2017. By way of filing O.A. 613 of 2017 the applicant approached this Tribunal. In terms of the Tribunal's order the authority issued Notification dated 02.11.2017 to join in the post of Headmaster in newly integrated government school at Sagar Block, South 24 Parganas District. Since both the appointment letters were contrary to the Public Service Commission's advertisement, the applicant submitted series of representations dated 08.12.2017, 03.01.2018, 11.03.2020, 29.06.2020, 31.10.2020 and 08.12.2020, but no reply has been given by the appointing authority.
