The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638 – WBAT / 2J-15/2016 dated 23rd November, 2022 issued in exercise of the powers conferred under Section 5(6) of the Administrative Tribunals Act, 1985.

The applicant has prayed for a direction directing the concerned respondent authorities to immediately publish the Seniority rules of the unified cadre of WBA&AS post-merger keeping the direct officers of 1999 batch above the mergerist officers who came into WBA&AS in 2001 by dint of merger of WB Jr. A & AS with WBA & AS and not by dint of promotion to WBA&AS taking into consideration the relevant rules and judicial orders including West Bengal Services (Determination of Seniority) Rules, 1981, WBCS (Executive) (Determination of Seniority) Rules, 2008.

The matter is admitted.
