The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 536 – WBAT / 2J-15/2016 dated 26<sup>th</sup> August, 2022 issued in exercise of the powers conferred under Section 5(6) of the Administrative Tribunals Act, 1985.

The instant application has been filed basically praying for the payment of present and arrear salary. As per the applicant, he moved this Tribunal earlier in O.A. No. 53 of 2021, which was disposed vide order dated 03.03.2021. As the order was not complied with, the applicant filed one CCP No. 40 of 2021 and in pursuance to that, the Director, Pension, Provident Fund & Group Insurance first his order dated 24.12.2021 allowing the applicant to join and directing the Joint Director. D.P.P.G., Uttarkanya to send all details of the applicant to the Judicial Department for taking action.

Subsequently, the applicant joined on 27.12.2021 and the Joint Director, D.P.P.G., Uttarkanya vide Memo. dated 28.12.2021 had sent Joining Report of the applicant and since then he has not been paid his due salary in this regard. He made a representation dated 09.02.2022 to the Deputy Secretary, Judicial Department but with no effect. Being aggrieved with, he has filed the instant application.

However, even after serving notice, none appeared on 29.08.2022 and 15.09.2022. The applicant was further directed to serve notice to the Respondent
