The instant application has been filed praying for following relief :-

- a) An order directing the respondents to forthwith comply the order passed by this Hon'ble Tribunal in OA-521 of 2009 and the order dated 21.06.2010 passed in OA-294 of 2010 and forthwith regularize the period of absence from 06.08.2003 to 19.08.2009 and also to allow the applicant all arrears of salaries and allowances after re-fixing and revising the scale of pay as per ROPA-2009 and also to pay the applicant regular salaries and allowances from 19.08.2009 to 08.11.2011 accordingly with interest at the market rate;
- b) Issuance of any other order or orders and/or direction as this Hon'ble Tribunal may deem fit and proper.

As per the applicant, the order dated 24.07.2009 and 21.06.2010 still has not been complied with or implemented. Therefore, he has prayed for implementation of the aforementioned orders within a stipulated period of time.

The counsel for the respondent has admitted that till date both the orders have not been implemented.

In view of the above, Respondent No. 2, Director of Health Services, West Bengal is directed to implement the order dated 24.07.2009 and 21.06.2010 within a period of six weeks from the date of the receipt of
