The instant application has been filed challenging the impugned decision dated 06.01.2017, which was communicated to the applicant on 16.07.2018. During the course of the hearing, the counsel for the applicant has drawn our attention to the letter dated 15.02.2019, issued by the Commissioner of Textiles (Sericulture) to the Joint Director of Textiles (Sericulture) asking for resubmission of all documents as per 23 point check list as required for applying for appointment of compassionate appointment.
