The matter is taken up by the single Bench pursuant to the order contained in the Notification No.638-WBAT/2J-15/2016 (Pt.-II) dated 23<sup>rd</sup> November, 2022 issued in exercise of the powers conferred under section 5(6) of the Administrative Tribunals Act, 1985.

The applicant has prayed for a direction to the respondent authorities to consider her application and allow her to join the G.N.M. course for the session 2022-2025 on "Trainee Reserve" facility.

The learned counsel draws my attention to the copy of the application she had filed on 01.09.2022 praying for "Trainee Reserve" facility to undergo the G.N.M. course for the years 2020-2025. Submission of Mr. Bhattacharjee is that despite furnishing this application, prior to commencement of the course, the respondent authorities have neither considered nor intimated her the decision.

On examination of the papers, it is evidently clear that the applicant as an HA (F) desiring to undergo a higher course, G.N.M. for the session 2022-2025 had indeed applied before the Deputy Director of Health Services (Nursing). On the last date of hearing the Tribunal had wondered whether the applicant can be still admitted belatedly for the post which has already commenced? Today, Mr. Bhattacharjee responds that as per instructions, it was made known to him that the Institute is willing to accept the candidates for the course provided she has been issued the order for Trainee Reserve facility by her employer.

However, Mr. D. Kole, learned counsel does not agree and he thinks it is futile for the applicant to join this three-years' course in which two years have
