The matter is taken up by the Single Bench pursuant to the Notification No. 949-WBAT/2J-15/2016 dated 24th December, 2020, issued in exercise of the powers conferred under sub section (6) of Section 5 of the Administrative Tribunals Act, 1985.

The instant application has been filed praying for direction upon the state authority to consider the case of the applicant for compassionate appointment. As per the applicant, his mother died on 19.09.2012. Subsequently, he had made an application for compassionate appointment which was forwarded by the authority on 30.01.2013 and subsequently vide Memo. dated 06.12.2016 Chief Medical Officer of Health, Murshidabad had forwarded the required information as asked by the then Joint Director of Health Services (Personnel), West Bengal, Swasthya Bhawan as well as fresh enquiry report of three-men committee to take necessary steps. However, thereafter no decision was communicated to the applicant. Being aggrieved with, he had filed one WP No. 21258 (W) of 2017 (Annexure-K) before the Hon'ble High Court at Calcutta which was disposed of by order dated 30.08.2017 for want of jurisdiction with a liberty to the applicant to take appropriate steps.

In view of the above, the applicant has filed the instant OA. During the course of the hearing, the counsel for the applicant has fairly submitted that it would suffice his purpose if the respondents would be directed to take final decision and communicate the same within a stipulated period of time as the applicant is suffering since 2012.

The counsel for the respondents has no objection to such proposition.
