Both the parties have submitted that they have no objection to be heard by the Single Bench.

The counsel for the applicant has drawn my attention to the earlier order dated 17.02.2022, whereby the B.D.O., Magrahat – II, Development Block, South 24 Parganas was directed to submit information with regard to the payment of salary for the period from August, 2015 to October, 2015 and whether any disciplinary proceeding has been initiated by them or not? On that date, the counsel appearing for the Director of Personnel and Ex-officio Chief Engineer appearing for the respondent No. 2 had placed one status report filed by the Director of Personnel and Ex-officio Chief Engineer.

Today none appears for the respondent No. 3 & 4. However, the B.D.O., Magrahat – II, Development Block, South 24 Parganas instead of filing of proper status report before this Bench had sent one e-mail to the Deputy Registrar, West Bengal Administrative Tribunal on 03.03.2022 for taking necessary action. Though this is not the way to file any status report before the court. However, from the perusal of the said communication dated 03.03.2022 as has been placed in the file by the Registry, it is noted that admittedly applicant was not paid salary from the month of August, 21015 to October, 2015 and was released from the office of B.D.O., Magrahat – II, Development Block, South 24 Parganas on

29.02.2016. It has been further stated that he has no information with regard to the initiation of the departmental proceeding against the applicant.

In view of the above, the respondent No. 3 is directed to make payment of due salary of the applicant for the period from August, 2015 to October, 2015 and to take appropriate steps to deposit the G.P.F. amount for afore-mentioned three months before the appropriate Authority as per Rules and Law within a period of six weeks from the date of receipt of the order. Accordingly, the O.A. is disposed of with no order as to costs.
