The matter is taken up pursuant to the order contained in the Notification No. 638-WBAT / 2J-15/2016 (Pt.-II) dated 23<sup>rd</sup> November, 2022 issued in exercise of the powers conferred under the Administrative Tribunals Act, 1985 and the Rules framed thereunder.
