The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt. – II) dated 23<sup>rd</sup> November, 2022 issued in exercise of the powers conferred under Section 5(6) of the Administrative Tribunals Act, 1985.

On consent of the learned counsel for the contesting parties, the case is taken up for consideration sitting singly.

The applicant's father working as a Resham karmi under the Directorate of Textile (Sericulture) died in harness on 12<sup>th</sup> March, 2012. Thereafter, Dipali Pasman, widow of the deceased filed an application for compassionate employment in favour of Manik Pasman, her son on 8<sup>th</sup> September, 2016. Later, the applicant Manik Pasman himself submitted an application on 14<sup>th</sup> September, 2017. Against such application, a three-men screening committee was constituted which enquired and submitted its report. Submission of Mr. D.K. Mukherjee, learned counsel for the applicant is that a direction be given to the respondent authority to consider and dispose of this application for compassionate employment.

Mr. M.N. Roy, learned counsel appearing on behalf of the State respondents submits that if such a direction is given, the same will be complied as per rules.

After hearing the submissions of the learned counsels, this application is disposed of by directing the respondent no. 2(ii) – the Commissioner, Textile and
