The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt.-II) dated 23<sup>rd</sup> November, 2022 issued in exercise of the powers conferred under Section 5(6) of the Administrative Tribunals Act, 1985.

On consent of the learned counsels for the contesting parties, the case is taken up for consideration sitting singly.

Affidavit of service filed be kept on record.

The applicant has prayed for a direction to the respondent authorities to expedite the process to his application for appointment on compassionate ground. The deceased Ramesh Sheel @ Ramesh Shil, a Group-D working under the Deputy Director of Sericulture, Jalpaiguri had died while in service on 21.07.2021. After his death, the applicant, the son had submitted a plain paper application for compassionate employment before the respondent authorities on 02.09.2021. Later, the applicant also furnished his details in the proforma application on 20.12.2022. Having received such application and after completion of initial enquiry, the Joint Director, Sericulture, Siliguri submitted a proposal before the Joint Director & Commissioner of Textiles and Sericulture, Siliguri on 02.01.2024. Submission of Mrs. Das is that despite submission of his application and the same having been forwarded to the competent authority on 02.01.2024, till date neither such application has been considered nor any intimation given to the applicant.

Appearing on behalf of the respondent authority, Mr. Banerjee, learned counsel submits that if a direction is given to the respondent authorities, the same will be considered as per rules.

Having heard the submissions and considering the facts and circumstances of this case, this application is disposed of by directing the Respondent No. 2, Deputy Secretary, Agriculture Department to complete the
