The matter is taken up by the single Bench pursuant to the order contained in the Notification No. 118-WBAT/1E-08/2003 (Pt.-II) dated 11th February, 2022 issued in exercise of the powers conferred under section 6 (5) of the Administrative Tribunals Act, 1985.

In the application Ratna Ghosh Roy (Kar), the applicant working in the post of Medical Technologist(Lab) under the supervision of Superintendent, Baruipur Sub Divisional and Super speciality Hospital in the district of South 24-Pargnas has prayed for certain reliefs, the relevant portion of which is as under :-

“...a. An order do issue directing the respondent authorities to count the past service rendered by the applicant in the capacity of “Medical Technologist(Lab)” since 16.06.2003 till her regularization made on 17.05.2007 within a stipulated time period for calculating the length of service for grant of full pension, as your applicant is anticipating her superannuation on 30.06.2023.

b. An order do issue directing the respondent authorities to dispose of the representation dated 12.04.2021 made before them within a stipulated time period after giving an opportunity of hearing to the applicant herein by passing a reasoned and speaking order to be communicated upon your applicant..”.

that since a representation dated 12th April, 2021 has been filed before the State respondents praying for regularisation of service taking into account the previous work as contractual lab technologist for the purpose of full pension upon completion of twenty years of service, the State authorities may be directed to consider the same.

Mr. G.P. Banerjee, learned advocate appearing on behalf of the State respondents submits if directed, the respondent authorities will consider the said representation in accordance with law.

Having heard the learned advocates for the parties and as prayed for on behalf of the applicant, the application is disposed of by directing the Director of Health Services, Directorate of Health Services, Government of West Bengal, - the respondent no. 2 to dispose of the said representation dated 12th April, 2021, being annexure 'D' to the application by passing a reasoned order to be communicated to the parties within fifteen weeks from the date of presentation of a copy of this order after giving an opportunity of hearing and after verifying the records and after considering the rules and the memo dated 7th January, 2009.
