The applicant had joined the service as a Staff Nurse in 1965, but due to her ailing husband, she discontinued her service with effect from 15.09.1981. It also appears from a Memo. No. 1038 dated 14.01.1993 that she had applied for voluntary retirement and her service book and other documents were submitted before the Principal Accountant General (A&E) West Bengal. It also appears from the recent correspondence No. 37/1(1) dated 04.02.2020, the Directorate of Health Services had asked the Medical Superintendent-cum-Vice Principal, Medical College & Hospital to take suitable action with regard to her representation for retiral benefits. Her last representation before the respondent authority appears to be on 14.12.2020 addressed to the Special Officer (Pension), Directorate of Health Services.
