The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt. II) dated 23rd November, 2022 issued in exercise of the powers conferred under Section 5 (6) of the Administrative Tribunals Act, 1985.

On consent of the learned counsels for the contesting parties, the case is taken up for consideration sitting singly.

Mr. N. Bera, learned counsel for the applicant referring to pages 43 and 44 submits that the information relating to his involvement in the criminal proceeding is factually incorrect and the applicant is not involved in any criminal cases. Therefore, his pensionary benefits be sanctioned and released to him.

Appearing on behalf of the department, Ms. Sarkar presents a copy of a reference from the I.C. of Kakdwip Police District. This letter addressed to the S.R.O.-II and D.D.O. of Kakdwip informs that the applicant Md. Abdus Salam Molla, Ex-Revenue Officer, then attached to B.L.&L.R.O. office, Kakdwip has no case registered against him. Further, another correspondence is presented in which the S.D.L.& L.R.O. informs the Additional District Magistrate and District Land and Land Reforms Officer, South 24-Parganas that there is no F.I.R. against Md. Abdus Salam Molla, Ex-Revenue Officer of B.L. & L.R.O. office, Kakdwip.

In view of these documents, Mr. Bera prays that the prayer of the applicant be considered for releasing his retiral benefits and other dues like Gratuity, Leave Salary, Commuted Value of Pension, Group Insurance,

Monthly Pension and arrears of pension.

In view of the above facts, this application is disposed of by directing the respondent no. 5, the Sub-Divisional Land and Land Reforms Officer, Kakdwip, South 24-Parganas to release the retiral dues along with arrears to the applicant within a period of four (04) months from the date of communication of this order. While processing these dues, the co-operation of the applicant will also be required. Therefore, the applicant is also directed to co-operate fully with the respondent authority in processing his case. Accordingly, this application is **disposed of**.
