It appears that earlier on 13<sup>th</sup> April, 2022 after hearing the learned advocates for the parties, the matter was admitted. Directions were issued to file reply and rejoinder and the matter was directed to appear under the heading “For Orders” today.

Mr. Sankha Ghosh, learned advocate appearing for the State respondents submits that reply is yet to be filed. On a query, it is submitted that no date has been announced for fixing the date for holding the selection process for Medical Technologist(Lab) Grade III.

Mr. Gautam Pathak Banerjee, learned advocate for the applicant referring to the order dated 15<sup>th</sup> June, 2022 passed in W.P.S.T. 43 of 2022, challenging the order dated 13<sup>th</sup> April, 2022 passed in O.A. 173 of 2022, refusing to pass interim order, submits that since no date for conducting the selection process has been announced, interim order, as prayed for, may be granted.

As prayed for by Mr. Ghosh, time to file reply is extended till 22<sup>nd</sup> July, 2022. Rejoinder, if any, by 5<sup>th</sup> August, 2022. Matter to appear under the heading “Hearing” on 25<sup>th</sup> August, 2022.

So far as the prayer for interim order is concerned, since in spite of the directions no reply has been filed on behalf of the State respondents and as it has been submitted on behalf of the respondents that the date for holding the selection process is yet to be announced, considering the facts and
