In this application Arijit Mondal, the applicant has prayed for certain reliefs, the relevant portion of which is as under :-

"...To direct the Respondents, their men and agents to produce the answer sheet of the Applicant before the Hon'ble Tribunal so that the real state can be brought to light..".

It appears that the applicant appeared in the selection process for the post of Constable in West Bengal Police, 2020. According to the applicant that though he had successfully answered in the written test, however, in the mark sheet column no marks has been given. Aggrieved this application has been filed.

Mr. S. Bhattacharjee, learned advocate for the applicant submits that the respondents, particularly the West Bengal Police Recruitment Board, - the respondent no. 2 (iii), may be directed to produce the answer sheets.

Mr. G.P. Banerjee, learned advocate for the State respondents, referring to page 15 of the application, submits that the applicant had made a mistake. The applicant had answered in the OMR sheet. All OMR sheets were scrutinized and computerised evaluation was done. As per records, the applicant had encoded his preliminary written test roll number incorrectly on his allotted OMR answer sheets. Hence, the Board was unable to evaluate his OMR answer sheet. As a result, the applicant was not short listed for PMT and PET and his candidature was

rejected.

Mr. Bhattacharjee, submits that leave may be granted to file representation before the authorities and the authorities may be directed to consider the same.

Having heard the learned advocates for the parties and considering the facts and circumstances of the case, the application is disposed of by granting liberty to the applicant to file representation ventilating his grievances before the West Bengal Police Recruitment Board, - the respondent no. 2(iii) within eight weeks along with a copy of this order downloaded from the website of the Tribunal. If representation is filed within the time as stipulated, the Chairman of the Board, - the respondent no. 2(iii) shall reply to the same indicating the cause of rejection within four weeks.
