the applicant on the plea that the departmental proceeding is pending. Submission is that in view of the memorandum dated 12th June, 1980, provisional promotion be given during pendency of the departmental proceeding.

Mr. S. Bhattacharjee submits that since the departmental proceedings were initiated pursuant to the memorandum dated 24^{th} July, 2019, as evident from annexure P – 6 to the application, no order in that regard may be passed.

Let the matter be heard after filing of reply and rejoinder. However, pendency of this application shall not prevent the respondent authorities to promote the applicant on the basis of memorandum dated 12th June, 1980 as prima facie I find that by memo dated 9th May, 2016, the department had decided to initiate the departmental proceedings against him.

Let a copy of this order be served on Drubojoyti Mazumdar, the private respondent no. 6 through the office of the Joint Secretary, Panchayat and Rural Development Department, the respondent no. 2(i) (b) by 12th April, 2021 and supplementary affidavit be affirmed and filed on the next date of hearing.
