In this application, Supriya Hazra and Baishali Hati, the applicants, who participated in the selection process for the post of Medical Technologist (RD) Grade III, have prayed for certain reliefs, the relevant portion of which is as under:

"a) An order do issue directing the respondent authorities to be give proper marks for passing Higher Secondary (10+2) having Physics, Chemistry and Biology and two years Diploma in Medical Technology in favour of the applicants and after reevaluating marks issued appointment letters in favour of the applicants herein for the post of Medical Technologist (Radio Diagnosis) of Medical Technologists Cadre of the West Bengal Sub-ordinate Health Services under Health & Family Welfare Department, Government of West Bengal within a stipulated time period.

b) An order do issue directing the respondent authorities to dispose of the representations by passing a reasoned and speaking order and to communicate the same upon the applicants herein after giving an opportunity of hearing, within a stipulated time period."

Submission is though representations both dated 5<sup>th</sup> January, 2022 were furnished by the applicants independently, those have not been considered by the respondent no.3. Aggrieved, this application has been filed. Prayer is the respondent no.3 may be directed to dispose of the said representations.

Mr.S.Ghosh, learned advocate for the State respondents submits that the marks awarded are just and proper. However, if directed, the respondents will consider the representations in accordance with law.

Having heard the learned advocates for the parties, the application is disposed of by granting liberty to the applicants to file separate representations afresh ventilating their grievances before the Secretary and Controller of Examinations, West Bengal Health Recruitment Board, Kolkata, the respondent no. 3 within four weeks along with a copy of this order downloaded from the website of the Tribunal. If representations are filed separately by the applicants, the respondent no.3 shall dispose of the same by passing reasoned orders to be communicated to the parties within fifteen weeks after verifying the records.
