The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt.-II) dated 23<sup>rd</sup> November, 2022 issued in exercise of the powers conferred under Section 5 (6) of the Administrative Tribunals Act, 1985.

On consent of the learned counsels for the contesting parties, the case is taken up for consideration sitting singly.

This is an application in which the applicant has prayed for a direction to the respondent authorities to expedite the process of offering appointment to him on compassionate ground. The fact of the case as stated by the applicant in this application is that his father, Niranjan Das had died while in service on 29.03.2005 as a "Resham Karmee" (Group-D) working under the Joint Director of Textiles, Sericulture, North Zone, Siliguri. Soon after the death of his father, the applicant, being the son, furnished a plain paper application on 14.11.2005 followed by an application in the prescribed proforma on 16.03.2011. Submission of Mr.Ghosh is, since the respondent authorities are not responding to these prayers for compassionate employment, a suitable direction may be given.

Mr.Ray, learned counsel appearing on behalf of the respondent authorities assures that if such a direction is given, the same will be complied as per the existing rules.
