The counsel for the applicants have prayed for leave to make appropriate correction to respondent no. 2 instead of respondent no. 3. Prayer is allowed.

The instant applicant has been filed basically asking for extension of benefit of para 2(iii) Memorandum No. 1033-F(P<sub>2</sub>) dated 08.02.2019 by way of enhancing the monthly remuneration to the petitioners, who are working as casual worker (Group-D staff). As per the applicants, they are entitled to get benefit of the memorandum dated 08.02.2019. During the course of the hearing, the counsel for the applicants have submitted that it would suffice the purpose of the applicants, if the respondent no. 6 i.e. District Magistrate and Collector of Murshidabad, be directed to consider the case of the applicants in the light of the Memorandum dated 08.02.2019 treating this OA as a representation.

The departmental representative appearing for respondent no. 5 have no objection with such proposition.

In view of the above, the District Magistrate and Collector of Murshidabad, i.e. respondent no. 6 is directed to consider the case of the applicants taking into consideration the Memorandum dated 08.02.2019 treating this OA as their representation and communicate his decision by
