The matter is taken up by the single Bench pursuant to the order contained in the Notification No.118-WBAT/1E-08/2003 (Pt.-II) dated 11th February, 2022 issued in exercise of the powers conferred under section 6(5) of the Administrative Tribunals Act, 1985.

In this application, Mr. Rathindranath Kar, the applicant has prayed for certain reliefs, the relevant portion of which is as under:

- "a) An order do issue directing the appropriate authority to allow the applicant benefits provided in there voluntary retirement scheme with effect from the date of his application for VRS on 26.06.2013.
- b) An order do issue directing the appropriate authority to allow him to join in his respective service with all consequential benefits."

It appears that the applicant joined the service as Sub-Assistant Engineer (Civil) under Binpur – II Block, Jhargram, Medinipur on 19th May, 1997 under the Assistant Engineer of Rural Water Supply. It appears that the applicant became seriously ill and had applied for voluntary retirement on 26th November, 2012.
