In the copy presented it is evident that the respondent No.3, the ADM&DL&LRO has conveyed to the learned counsel that the applicant, being a dismissed employee, is not entitled to any retiral benefits like pension, gratuity, leave salary, etc. However, the benefits which he was entitled to like GISS and GPF have already been disbursed to him by the SDL&LRO,
