In this application, Bharati Majhi, the applicant is the wife of Late Bhakta Kumar Majhi, ex-Night Guard, attached to the office of the Revenue Inspector under Block Land and Land Reforms Officer, Purbasthali-II, Burdwan. The employee, late Bhakta Kumar Majhi died in harness on 17th November, 2011. The applicant within a year from the death of her husband made an application before the respondent authorities for her employment on compassionate ground. The application was considered in her favour and the Joint Secretary, Land and Land Reforms Department, Govt. of West Bengal informed the Director of Land Records and Surveys and Joint Land Reforms Commissioner, West Bengal on 07.12.2015 in the following words :-

a) After careful examination of the matter, the undersigned is directed by the order of the Governor to say that the Governor has been pleased, in terms of

Labour Department Notification No. 251-Emp dated 03.12.2013, to accord approval for offering employment assistance to Smt. Bharati Majhi, wife of Late Bhakta Kr. Majhi, against a vacancy of Group-D post as Group-D in the exempted category of died-inharness as per 100 point roster under his control subject to fulfilment of other formalities like police verification, medical examination etc. as per rules...

As a follow up, the Director of Land Records and Surveys and Joint Land Reforms Commissioner, West Bengal wrote to the District Land and Land Reforms Officer, Burdwan on 21.12.2015 advising in the letter "to appoint Smjt. Bharati Majhi in the post of Group-D under his control subject to fulfilment of Police Verification, Medical Examination etc. As per existing rules."

Therefore, the District Land and Land Reforms Officer, Burdwan asked the applicant to appear before the authority on 13.01.2016 along with few documents like photo and relevant documents in connection with the appointment on compassionate ground. The applicant duly appeared before the District Land and Land Reforms Officer on 13.01.2016 and submitted all the relevant documents. This was also followed by the applicant's Medical Examination, in which she was declared fit by the Medical Board. The Police Verification Roll was filled up and submitted by the applicant along with Medical Certificate on 08.12.2016.

Surprisingly, after the approval and after completion of all

the formalities, she received a letter from the District Land and Land Reforms Officer on 24.10.2017 informing the applicant that "Government has considered her "Unsuitable" for employment in the post of Group-D", but no reason was mentioned as to why she was found unsuitable at this late stage. The applicant states that she was never convicted or charge sheeted by the Police in connection with any civil or criminal proceedings.

Since the above stated letter of rejection does not mention the reason why she was found unsuitable, she made a representation on 20.12.20185 before the respondent Nos. 3 & 4 for consideration of her case by withdrawing the impugned order dated 24.10.2017. However, this representation has remained unheeded and unreplied, till date.

Now before this Tribunal she has sought the following reliefs the relevant portion is quoted as under :-

a) "An order thereby quashing and/or setting aside the impugned order dated 24.10.2017 passed by the Additional District Magistrate and District Land and Land Reforms Officer, Purba Bardhaman, the respondent no. 3 herein thereby considering the applicant unsuitable for employment on compassionate ground (Annexure-A/8)".

On 18.09.2019, the Division Bench of the Tribunal noted that although Home & Hill Affairs Deptt. has been made a party but none appears on its behalf and no reply has also been filed. It

directs Respondent No. 5- the Principal Secretary, Home & Hill Affairs Department, Internal Security Branch, Secret Section, Govt. of West Bengal to provide information for such findings of unsuitability with regard to the applicant in a sealed cover by the next date. As directed, the respondents had submitted a note sheet in a sealed cover.

In the reply given by the Secretary, Land and Land Reforms Department, Government of West Bengal and the Additional District Magistrate and District Land and Land Reforms Officer, Burdwan Rajbari-I, Purba Bardhaman, the respondent No. 1 & 3 states the following points are stated :-

It appears from the record that the reason given for declaring her "Unsuitable" in her educational qualification, which is Class-V. Class VIII is the minimum qualification required for a Group-D post. It is alos important to note that the LRC & Secretary of the L & L R Deptt. had condoned this criteria, as explained by the DLLRO in his reply as quoted below :-

a) "That the educational qualification of Smt. Bharati Majhi was Class –V passed where for the appointment to the post of Group-D a candidate should be minimum Class VIII passed. However, under the compassionate employment scheme, a relaxation in educational qualification can be granted to eligible cases for appointment to the post of Group-D with the approval of the concerned Additional Chief Secretary/Principal

Secretary/Secretary of the Department. Accordingly, the Secretary, Land and Land Reforms Department, Govt. of West Bengal condoned the deficiency in educational qualification for Smt. Bharati Majhi on 02.09.2015, copy of which was submitted and kept in record.

b) That the Additional District Magistrate and District Land and Land Reforms Officer, the respondent No. 3 in their replies submits that although such an offer of employment, with due approval of the appropriate authority, was made to Smt. Bharati Majhi, it is not their fault for this employment not to have materialized."

This decision of the Government was communicated to the applicant by the respondent No. 3 on 24.10.2017.

After hearing the learned advocates and perusing the records, it appears that a serious travesty of justice has taken place in this case. I find that a person's legitimate right of employment on compassionate ground was first granted and later snatched from her, citing a frivolous reason and declaring her "unsuitable". It is also interesting to find how one arm of the Government offers the employment and the other arm rejects it.

It is also absurd to find that when the Governor is pleased to approve the employment, some official has the temerity to reject it.

The reason stated for this afterthought rejection of "unsuitability" due to her lack of qualifying education is of Class V in place of Class VIII. When the authorised officer, the Secretary of the Land and Land Reforms Department has condoned this, then why was it rejected by someone e lse.

The applicant has stated very clearly that she does not have any civil or criminal proceedings in any court against her. To support her claim, the Police Report on her verification, reported by Senior Superintendent of Police (C), Intelligence Branch clearly states that "there is nothing adverse against her either in Intelligence Bureau or in the Superintendent of Police, D.I.B. Burdwan."

I find serious miscarriage of justice has been done to the applicant by first approving her employment and later, on a very weak ground, rejecting what was approved. Therefore, I do not find any merit to agree with the respondents in denying her later what was offered earlier.

Thus, the impugned order Momo 34 (243)/E/2014 dated 24.10.2017 of Additional District Magistrate and District Land & Land Reforms Officer, Purba Bardhaman is quashed and set aside. The reliefs sought by the applicant in the prayer in this OA-201 of 2019 are allowed. The respondents 1, 2 & 3 are directed to issue her the final Appointment Letter to Bharti Majhi and allow her to join without any further hindrances, within a period of four weeks from the date of receipt of this Order to be downloaded from the
