The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 638-WBAT/2J-15/2016 (Pt.-II) dated 23rd November, 2022 issued in exercise of the powers conferred under Section 5 (6) of the Administrative Tribunals Act, 1985.

On consent of the learned counsels for the contesting parties, the case is taken up for consideration sitting singly.

From the introductory submissions of the learned counsels representing all the sides, it appears that the Public Service Commission on behalf of the erstwhile Staff Selection Commission made the following statements in the reply filed before this Tribunal.

"From some scanty information as provided by the erstwhile WBSSC, we came to learn that during processing of the result of S.I. of Food (2nd Nomination) though Result Processing Software some errors crept in and as a result of which names of 43 candidates belonging to OBC 'A' (EC) category who scored higher marks than the minimum marks obtained by the nominated candidates had been left out inadvertently. This error was totally unintentional, which occurred during the computing of the final results."
