The matter is taken up by the single Bench pursuant to the Notification No. 949-WBAT/2J-15/2016 dated 24<sup>th</sup> December, 2020 issued in exercise of the powers conferred under sub-section (6) of Section 5 of the Administrative Tribunals Act, 1985.

In this application, Chandan Mardi – the applicant has prayed for certain reliefs, the relevant portion of which is as under:

".....(a) A mandatory order directing the respondent authorities to complete all process of compassionate appointment of the applicant from death in harness category without committing any further delay keeping in view that a period of eight years has already expired after the death of the applicant's father and to issue order of appointment of the applicant on compassionate ground immediately on completion of the process of compassionate appointment and to act in accordance with law."

It appears that the father of the applicant, Dhena Mardi was a Krishi Shramik in Sisal Plantation Farm, Rajnagar, Birbhumn and had expired on 10<sup>th</sup> August, 2012, while in service leaving behind the heirs and legal representatives, the names of whom are enumerated in paragraph 6.3 of the original application. It is evident that the applicant on 17<sup>th</sup> August, 2012 had filed an application before the Deputy Director of Agriculture

(Administration) praying for appointment on compassionate ground. It has been stated that the heirs including the younger brother of the applicant have no objection if the applicant is provided with appointment on compassionate ground.
