The matter is taken up by the single Bench pursuant to the order contained in the Notification No. 496-WBAT/1E-08/2003 (Pt.-II) dated 4<sup>th</sup> August, 2022 issued in exercise of the powers conferred under section 6 (5) of the Administrative Tribunals Act, 1985.

In the application, Satya Dulal Acharya, the applicant, who was a Krishi Prajukti Sahayak under Assistant D.A.Deganga, 24 Paraganas (N), has prayed for certain reliefs, the relevant portion of which is as under:

*“ A. An appropriate order, directing the respondents, their agents, servants and subordinates to consider the application made by the applicant with regard to his promotion dated 24.7.2020 sympathetically and dispose the said application upon giving an opportunity of hearing within a period of 4 weeks and to pass a reasoned order within a period of 2 weeks thereafter.”*

Mr.G.Haldar, learned advocate for the applicant submits that though by memo. dated 27<sup>th</sup> October, 2016 the applicant was allowed to join the promotional post under SAS-II Cadre as a special case with a posting as Assistant A.E.O (I) under Assistant D.A.Deganga, North 24 Paraganas, as at the relevant point of time the applicant met with an accident and could not join

the post, the representation dated 24<sup>th</sup> July, 2020 may be directed to be considered by the respondents sympathetically as he has superannuated on 30<sup>th</sup> September, 2020.

Mr.G.P.Banerjee, learned advocate appearing on behalf of the State respondents submits that as the applicant has superannuated and thereafter has filed the instant application, no order may be passed.

Having heard the learned advocates for the parties and considering the facts and circumstances of the case, the application is disposed of by directing the Director of Agriculture, Government of West Bengal, Kolkata, the respondent no. 3 to give reply to the representation dated 24<sup>th</sup> July, 2020, being Annexure- D to the application, to the applicant within eight weeks from the date of obtaining a copy of this order downloaded from the website of the Tribunal.
