The matter is taken up by the single Bench pursuant to the order contained in the Notification No. 118-WBAT/1E-08/2003 (Pt.-II) dated 11<sup>th</sup> February, 2022 issued in exercise of the powers conferred under section 6 (5) of the Administrative Tribunals Act, 1985.

In this application, Subrata Kumar Sen, the applicant, has prayed for several reliefs, the relevant portion of which is as under:

“ (a) An order do issue thereby directing the respondent authorities to transfer and allow posting to your applicant in terms of the transfer policy formulated vide Memorandum No. 937-SE (A) /6T-04/11 dated, the 29<sup>th</sup> November, 2011, more specifically in light of the policy depicted in Zone-II B (iv) within a stipulated time period as per vacancy.

(b) An order do issue thereby directing the respondent authorities to consider and dispose of the representation dated 23.02.2022 in the light of the Memorandum No. 937-SE (A) /6T-04/11 dated, the 29<sup>th</sup> November, 2011, more specifically in light of the policy depicted in Zone-II B (iv) by passing a reasoned and speaking order in accordance with law after giving an opportunity of hearing and to communicate the decision thereof to your applicant within a stipulated time period.”
