The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 118-WBAT/1E-08/2003 (Pt.-II) dated 11th February, 2022 issued in exercise of the powers conferred under Section 6(5) of the Administrative Tribunals Act, 1985.

The instant application has been filed mainly challenging the impugned 2nd show cause notice wherein as per the applicant instead of tentative opinion, the Disciplinary Authority had already reached to the conclusion of punishment of dismissal, therefore, in reply to the said show cause notice would be futile exercise. However, the counsel for the applicant today has placed one representation filed before the Disciplinary Authority with regard to the 2nd show cause notice. He has further prayed for an adinterim order by way of preventing the authority to pass any final order before the conclusion of the application. Let the copy of the reply to the 2nd show cause notice be kept on record. It has been further submitted that until and unless an interim protection be given to the applicant, as the respondent has reached to the final conclusion to dismiss the applicant, he will suffer irreparable loss and injuries. Therefore, he has moved this application ex-parte and has prayed for some time to serve the copy of the application to all the respondents.

I have heard the counsel for the applicant and perused the record. It is noted that the Disciplinary Authority in the 2nd show cause notice has opined that he had already reached to the conclusion to impose penalty of dismissal though the 2nd show cause notice is a provisional one to grant opportunity to the applicant to place his case before imposing any punishment. Since balance of convenience in favour of the applicant, I direct the Respondent No. 3 not to take any further steps till the next date under Section
