facts and circumstances of the case, the application is disposed of by granting liberty to the applicant to file a representation ventilating his grievances afresh before the Director of Health Services, Government of West Bengal, Kolkata, the respondent no.2 for posting him as acting or permanent BMOH within a period of four weeks. If such representation is filed within the time as stipulated, the respondent no.2 shall dispose of the same by passing a reasoned order to be communicated to the parties within eight weeks after giving an opportunity of hearing and after verifying the records.
