In this application, the applicants who had participated in the selection process for the post of Constables in Calcutta Police pursuant to the Employment Notice No. 01/2012/KPRB have prayed for the following :

“DIRECTION do issue quashing and setting aside the call letters all dated 13.06.2015 being Annexure “A-7” hereto, the notice dated 15.06.2015 and the consequent category wise and merit wise list of the provisionally selected H.G. personnel (Male) in C/W recruitment to the post of constable (Male) in Kolkata Police, 2012 being Annexure “A-8” hereto and thereupon directing the respondent authorities to act and proceed in accordance with the recruitment rules and the Employment Notice No. 01/2012/KPRB as upheld by the Ld. Tribunal in O.A. Nos. 88 of 2013 and 101 of 2013 as affirmed by the Hon'ble High Court at Calcutta in W.P.S.T. Nos. 240 of 2013 and 247 of 2013 by reserving/setting apart 10% of the vacancies, horizontal reservation, in the post of Constables in Calcutta Police for serving Home Guards and thereupon to consider the candidature of your applicants in the said reserve vacancies and thereafter to take the selection process to its logical conclusion by calling such candidates for interview afresh and declare the results in accordance therewith”.

Calcutta High Court in W.P.S.T. No. 240 of 2013, the Police authorities have filled up the posts of Constables and 10% vacancies in the horizontal reservation for the post of Constable in Calcutta Police for serving Home Guards have also been filled up pursuant to the employment notice no. 01/2012/KPRB which is also evident from the order dated 28th February, 2017 passed in CPAN 1941 of 2015 in WPST No. 240 of 2013 (Arabinda Das & Ors. Vs. Sib Shankar Dutta). Submission is since the contempt application was dismissed by the said order dated 28th February, 2017, which means that the directions of the Hon'ble High Court, Calcutta passed in WPST No. 240 of 2013 have been complied with, nothing remains to be decided in the original application.

We find that the submission made on behalf of the respondents is correct. Therefore, no further order is passed on the application. The application is disposed of.
