Once the applicant furnishes such a representation enclosing relevant documents and after examination, if the prayer is found to be legitimate and bonafide of the applicant as the wife of the deceased employee is established to the satisfaction of the respondent authorities, the authorities will initiate steps to provide Family Pension to the applicant.
