The matter is taken up by the Single Bench pursuant to the order contained in the Notification No. 118-WBAT/1E-08/2003 (Pt.-II) dated 11<sup>th</sup> February, 2022 issued in exercise of the powers conferred under Section 6(5) of the Administrative Tribunals Act, 1985.

As per the counsel for the applicant, the applicant was initially appointed in a work-charged establishment on compassionate ground vide order dated 31.08.1989 and subsequently he was brought into regular establishment as orderly peon vide order dated 18.11.1996 and subsequently he was promoted to the post of Barkandaz on 10.09.2001. As per the counsel for the applicant, in the meantime, he has got increments and other benefits under different ROPA. However, he was not granted benefit under CAS for completion of 8 (eight) years and 10 (ten) years of service and had submitted representation before the authority and subsequently vide order dated 31.07.2018, the Executive Engineer, Mayurakshi Head Quarters Division, Suri, Birbhum had asked for post-facto permission as his appointment to the post of office peon as well as Barkandaz was made on exigency basis without proper government approval.

However, he has further recorded that his all appointments and other benefits were recorded as an entry to the service Book. However, till date, neither any final decision has been communicated to the applicant nor he has been granted CAS benefit. Being aggrieved with, the counsel for the applicant has filed this instant application.

The counsel for the respondent has prayed for time to file reply.

Prayer is allowed.
